**OBJECTIVES**

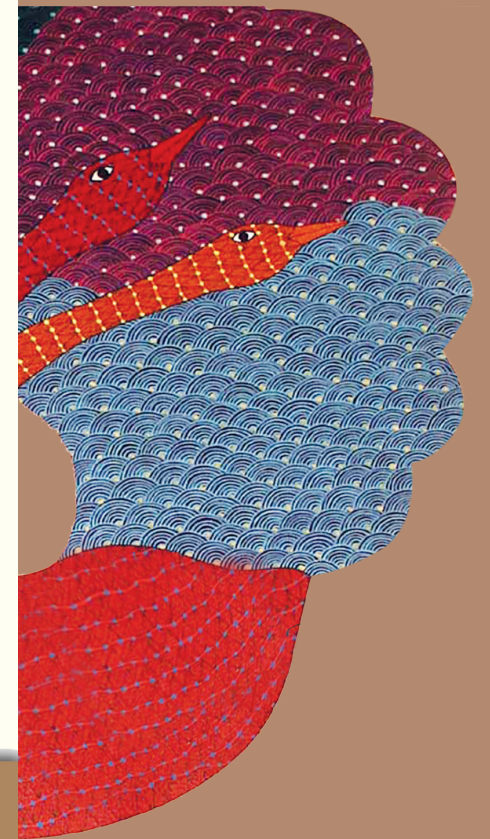
- (1) To assess the extent of implementation and impact of the 15 point program of the Prime Minister on the minority community population.
- (2) To undertake work to facilitate access of the minority community to their social, economic & legal entitlements.
- (3) To understand and bring forth the systemic/ policy gaps in the implementation of the program.
- (4) To undertake advocacy efforts with the district, state and national level government departments and officers and other stake holders to strengthen policy initiatives, institutional functioning and ensure better implementation of the program and the benefits to reach the community.
- (5) To build capacities of lawyers and para legal on the issue of minority rights and socio-economic rights to work on the issue in long term. The mandate of the project was to work with 15 Point Program of the Prime Minister and Multi-Sectoral Development Program.
