SCOPE AND OBJECTIVE:

The event is an effort to provide a platform for practitioners to share their experiences on ensuring land rights for different vulnerable sections of society. It will focus on how different strategies have been used by people in their struggle to ensure land rights, It will identify challenges faced by various social movements in the process of ensuring that the Dalits, women and Muslims are able to access their land rights. It will draw upon lessons from practical experience of what works and what does not work in terms of strategies and practices. The event will have an expert to give a broad thematic over view followed by group discussion amongst participants to cull out experiential learning.

The event can be attended by Advocates and Activists practicing on the issue of land rights.
