Supply of Food Grains and other assistance to the inmates of Relief Camps

Expenditure on food grains amounts to approx 950 lakhs.

Moreover, 470 lakhs were given @ Rs. 7 per head per day for miscellaneous expenses.

Food Grains to BPL Families in the Riot Affected Areas*

On an average 22.7 lakh families were disbursed food grains per month during May 2002 to October 2002.

Rehabilitation of Small Business :

For the approx. 3150 applications, Rs. 10 crores sanctioned.

Rs. 9.5 crores disbursed in approx. 2900 cases.

Subsidy of about 156 lakhs in approx. 2600 cases.

Direct finance from Gujarat Minorities Finance and Development Corporation of Rs. 430 lakhs in about 1850 cases.

Loans to Industries / Shops and Hotels

For the approx. 2850 applications, Rs. 61 crores sanctioned as loan.

Rs. 53 crores disbursed in approx. 2700 cases as loan.

Subsidy of about 580 lakhs in approx. 2350 cases.

Assistance to Industry & Commerce

- A. Interest subsidies of 4% flat rate to affected units
- B. Deferment of Sales Tax for 5 years
- C. Deferment of Electrical Duty for a period of one year payable in 36 installments
- D. Restructuring of existing loan
- E. Job security to all workers working before riot in the affected units.

About 435 widows (not necessarily widowed during riots) were enrolled under the State Governments Pension Scheme.

180 women and 120 children

Steps for Livelihood Restoration of Women (NORAD Scheme)

89 livelihood projects sanctioned for 6000 beneficiaries and Rs. 2.5 crores sanctioned approx.

Expenditure on Relief and Rehabilitation

The total expenditure incurred on Relief Camps and Rehabilitation is approx. Rs. 127 crores.

Health

2,30,000 cases were attended and government spent 35 lakhs on medicines etc.
